**ORDER U/S.12AA(1)(b)(i) OF THE INCOME TAX ACT, 1961:**

1. As constituted by the Memorandum of Association (MoA), registered on 08.10.2015, the above society has filed an application in Form No.10A for Registration u/s. 12A(1)(aa) of the Income Tax Act, 1961 on 18.08.2016. After filing the application, the applicant has made amendment to its MoA on 25.11.2016.
2. Accordingly, the said society is hereby registered and assigned URN: AAEAM2716J/07/16-17/S-1537 in the register maintained in this office. This registration is granted with effect from 18.08.2016.
3. The registration does not ipso facto exempt the income unless the provisions of Sections 11, 12 and 13 of the I.T. Act, 1961 are adhered to.
4. The applicant shall comply with the provisions of Section 139(4A).
5. No amendment in the MoA /Trust Deed shall be effected without the prior approval of the Commissioner of Income Tax (Exemptions), Hyderabad.
6. This society is henceforth assessable by the Income Tax Officer(Exemptions), Ward-2, Hyderabad.
7. In terms Section 12AA(3), if the activities of the society are found to be not genuine or not being carried out in accordance with the objects of the society, the registration granted vide this order shall be liable for cancellation.
